3. Target Date Funds are designed considering a target return with an specific investment time horizon.

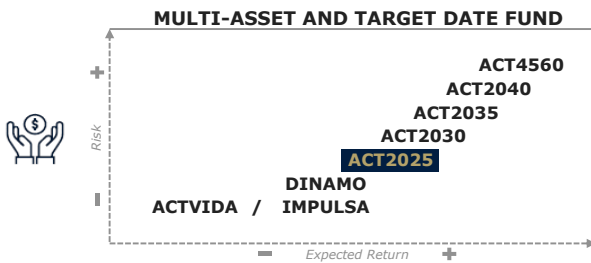

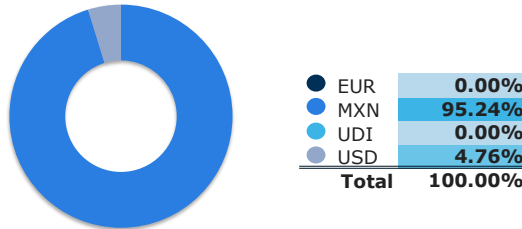

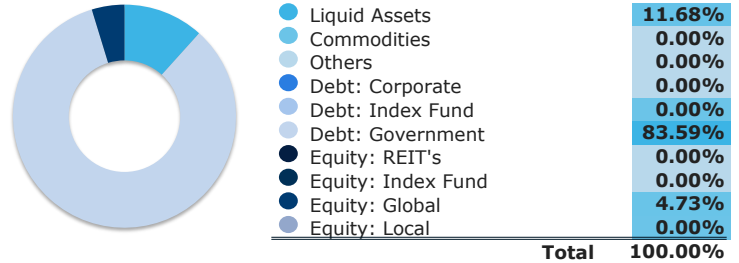

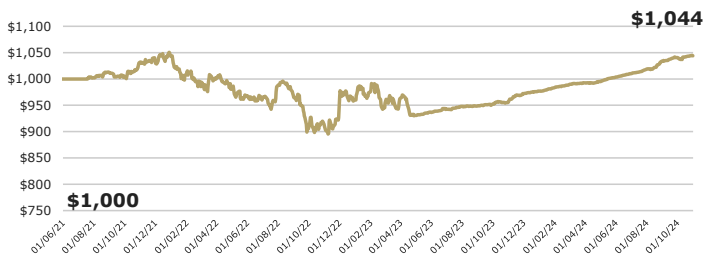


## ASSET CLASS BREAKDOWN<sup>1</sup>

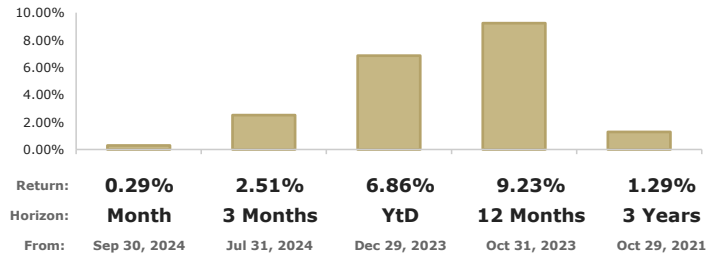
